1. I understand that to be eligible to participate as a contestant in the Contest, I :
  - A. Must hold a passport of the **Territory** I represent; and
  - B. Must have been selected from a female competition conducted in the **Territory** or alternatively must have been nominated by the **Sponsor with the approval from the Organizer**; and
  - C. Must be single and have never been married; and
  - D. Shall have attained the age of 18 years and not older than 28 years on or before 12<sup>th</sup> November 2009; and
  - E. Must have minimum height of 5'4 (164.6cm); and

- F. Must never been given birth; and
  - G. Must be of good health and
  - H. Must be of good moral character and should not have posed nude for any Adult magazine, photos must not be found nude in the internet on undesirable web pages; and
  - I. Possess all the qualities of a professional female model, i.e. poise, charm personality and figure, etc.; and
  - J. Must be cooperative and willing to abide by the directions and advice given by the authorized personnel of the **Organizer**; and
  - K. Must be a person whose background or character is not likely to bring into disrepute the **Contest**, the **Sponsors**, the **Organizer** or any person associated with them.
  - L. Must have not been convicted of crime; and
  - M. Must have a reasonable knowledge of and **be able to communicate in English** in addition to my native language; and
  - N. Must have no tattoos unless they are either in a place in a place, which cannot be seen when wearing swimwear, or can be hidden with cosmetics.
2. I hereby declare that :
- a. I have satisfied each and every requirement of eligibility set out in Clauses 1(A), 1(B), 1(C), 1(D), 1(E), 1(F), 1(G), 1(H), 1(I), 1(J) and 1(L) above. I shall satisfy the requirements sets out in Clause 1(M) hereof; and
  - b. All the information supplied by me in the General Information Form is true and accurate; and
  - c. I shall as and when requested, furnish the **Organizer** with all such statutory declaration(s) or notarized document(s) or document(s) signed or issue by government departments in the **Territory** in relation to any matters referred to in this form, the General Information Form; and
  - d. This agreement as a whole is for my own benefit
3. I hereby undertake to arrive and depart the host City Hong Kong , on the date(s) to be specified by the **Organizer**.
4. a. I understand that I have to bring the following items with me to the Contest and hereby undertake that I shall have them in my possession upon my arrival in Hong Kong :
- I. A wardrobe adequate for all activities in relation to the **Contest** including but not limited to publicity, rehearsals and appearances which wardrobe must include **one long evening gown, one Fashion outfit, one National Costume, one swimsuit**, and appropriate footwear and accessories for these outfits as per the brief to be supplied by the **Organizer**; and

- II. All clothing, footwear and articles for my daily use; and
- III. At least US\$200.00 to cover my incidental expenses.

5. a. I understand that the **Organizer** shall furnish me with reasonable accommodation (maximum two delegates to a room), and the **Organizer** shall have the sole right to determine their room-mate. Meals – (breakfast, lunch and dinner) will be provided by the **Organizer** – all meals will be standard meals. No special meals will be catered. Local transportation from the date that the **Delegate** arrives in Hong Kong, but not earlier than the dates to be specified by the **Organizer** pursuant to Clause 7(b) to the conclusion thereof marked by the election of ‘Miss World Peace 2006’ (herein referred to as the ‘**Winner**’).

Should I arrive earlier than or depart later than the dates specified by the **Organizer**, then I understand that I will be responsible for the payment of this accommodation and agree to pay in full prior to my arrival in Hong Kong, unless other arrangements have been made with the **Organizer** and confirmed in writing.

- b. I declare that the **Organizer** shall have the absolute and unfettered discretion in the choice and arrangement of accommodation, meals and transportation.
6. I understand that whilst in Hong Kong for the purpose of the **Contest**, I shall :
- a. Cooperate with the chaperons (hereinafter referred to as ‘the **Delegate Coordinator**’) assigned to me from time to time for my protection and welfare during my stay in Hong Kong and
  - b. Obey all directions and advice given to me by the **Delegate Coordinator**; and
  - c. Abide by all directions and advice given by authorized personnel of the **Organizer**, and
  - d. Punctually keep all appointments which require my presence; and
  - e. Reside and stay only at the accommodation provide for by the **Organizer** and not to depart therefrom save for the purpose of Clause 6(b). above; and
  - f. At the request of the authorized personnel of the **Organizer** or the **Delegate Coordinator**, be examined by a medical practitioner nominated by the **Organizer** at their expense.
7. Further I agree to the following :
- a. While spouse or parent(s) or guardian may accompany me at their own expense, control over my activities whilst I am in Hong Kong for the purpose of the Contest shall rest **solely** with the **Organizer** and the **Delegate Coordinator**; and

- b. That I am not authorized to incur, nor shall I incur, any debts on behalf of the **Organizer** or with respect to the **Contest**; and
  - c. I will abide by the judges' decision; and
  - d. I will depart Hong Kong to my home no later than the day after the selection of the **Winner** arrangements with the **Organizer** and confirmed in writing.
8. I hereby declare and acknowledge that the **Organizer** shall have the unfettered rights and discretion at all times to do any of the following things.
- a. to reject without stating any reasons in regard to my application to participate in the **Contest**;
  - b. to withdraw me from the Contest at any stage without stating any reasons;
  - c. to cancel, postpone or bring forward the scheduled date of the **Contest**.
  - d. In the case of dispute following the election of the **Winner** or the runner-up or other title holders, the **Organizer** may withhold and award of titles or prizes until the dispute is settled any way in its absolute discretion award such title and/or prize to the other contestant(s) in the **Contest**.
  - e. In the case of dispute arising out of anything herein contained the **Organizer** has the sole discretion to interpret these presents and the **Organizer** decision upon such interpretation is final and binding on me.

If I am elected **Winner** or as one or the first two runners-up or awarded any titles, I shall as conditions precedent to my election :

- a. Not enter into any female competitions or similar contests for a period of twenty-four (24) calendar months following the awarding of the **Winner** (hereinafter referred to as the '**Year of Office**') without prior written consent of the **Organizer**.   - b. at the expense of the **Organizer**, participate in all activities whether promotional publicity or otherwise wherein the prize of **MISS WORLD PEACE 2006** will be presented or such activities that the **Organizer** may designate.
  - c. During the **Year of Office**, travel to any country nominated by the **Organizer** on a date(s) to be specified to participate in all meeting, events, promotional and publicity activities and any other activities upon the request(s) of the **Organizer** and at it's expense.
  - d. During the **Year of Office**, visit the needy country nominated by the **Organizer** under an obligation.
  - e. I shall also follow all directions given by the authorized personnel of the **Organizer** in respect of the aforesaid activities.
  - f. I shall appoint the **Organizer** as my exclusive manager and agent at a fee equivalent 30% of appearances, advertising endorsements, modeling, stage, screen or television appearances, recording and photographic projects whether commercial or otherwise which may be undertaken by me during the **Year of Office**.
  - g. I understand that any moneys earned in my capacity as **Winner** will be paid to me less commissions and any agreed expenses, on receipt of cleared funds by the **Organizer** who will make every due effort to expedite payment by clients.
12. If I am in breach of any one of the warranties or undertakings herein contained or if I have made any false undertakings herein contained or if I have made any false declaration in this Agreement, the **Organizer** may in its absolute discretion :
- a. Send me home without payment of prize money or award of prizes and deprive me of the title awarded;
